4a (Code:) (Expenses \$ 440,273. including grants of \$ 304,814.) (Revenue \$) Friends of Acadia makes grants from its Acadia Trails Forever project fund to the ANP trails program to maintain the park's 153 miles of trails. Along with the usual erosion repair, projects in 2018 included rehabilitation of important sections of the Beech Mountain trails, the Gorham Mountain Trail, the Kane Path, the Seaside Path, the Valley Cove Trail, and the Bubble and Jordan Pond Path, including the re-construction of a northward spur from the intersection with the Canon Brook Trail.

4b (Code:) (Expenses \$ 287,631. including grants of \$ 199,136.) (Revenue \$) The Island Explorer is a fare-free, seasonal, propane-powered bus system that runs through Acadia National Park and its surrounding gateway communities. Since its first day of operation in 1999, over 7.8 million visitors have ridden the bus, an estimated 2.9 million private vehicle trips have been eliminated, reducing smog causing pollutants by an estimated 38.2 tons and greenhouse gas emissions by over 25,000 tons. Friends of Acadia has been involved with the bus systems since its inception, helping to secure and grant over \$3 million in funds from L.L. Bean and others to enable the system to grow. Friends of Acadia's grant helps to support the operating costs of 34 buses on Mount Desert Island, and two on the Schoodic peninsula.

4c (Code:) (Expenses \$ 538,467. including grants of \$ 357,700.) (Revenue \$) The Carriage Road maintenance grant makes possible the salaries of six Acadia National Park workers who perform regular maintenance of the park's 44 miles of historic carriage roads. In 2018, in addition to normal yearly upkeep, the workers opened up four historic vistas, repaired joint mortar on four carriage road bridges, and completed overhead cutting on 8.5 miles of the carriage roads. An arborist, the carriage road crew, and volunteers continued to repair the back drains that direct water from the landscape surrounding the carriage roads to the culverts. This program uses thousands of volunteer hours from FOA's volunteer program, and the Acadia Youth Conservation Corps students who are supported by another FOA endowment.
