4a (Code:) (Expenses \$ 393,046. including grants of \$ 240,000.) (Revenue \$) Friends of Acadia makes grants from its Acadia Trails Forever project fund to the ANP trails program to maintain the park's 153 miles of trails. Along with the usual erosion repair, and many special projects, one major accomplishment in 2020 was completion of the Seaside Path. The entire trail crew began on Seaside in early May. As new workers signed on, they went to Seaside. Material stockpiled the previous winter was applied to the trail, new materials were brought in. The mechanized finishing of the project included two small excavators, 4 ATVs with carts, a fleet of Canycom material haulers, and plenty of handwork.

4b (Code:) (Expenses \$ 217,177. including grants of \$ 129,406.) (Revenue \$) The Carriage Road maintenance grant makes possible the salaries of six Acadia National Park workers who perform regular maintenance of the park's 44 miles of historic carriage roads. In 2020, in addition to normal yearly upkeep, the workers spent several months re-ditching efforts took place in the Witch Hole and Paradise Hill areas. Dead and low-hanging limbs were cut for safety and to allow room for dump truck and emergency vehicle passage. The cutting created a "tent-like" effect of branches that direct rainfall downward to the trunk, reducing the amount of water that falls onto the road surface. Opening the canopy also allows the road surface to dry faster, further reducing damage. Care was taken to reduce the visibility of cuts and scars to maintain the overall natural aesthetic.

4c (Code:) (Expenses \$ 2,168,609. including grants of \$ 678,849.) (Revenue \$) Additionally, Friends of Acadia contributes to a variety of community outreach events such as Take Pride in Acadia, National Trails Day, and Earth Day Roadside Clean-up. In partnership with Acadia National Park, Friends implements and contributes to other programs including the Summit Stewards, the Wild Garden of Acadia, the Acadia Winter Trails Association, invasive plant eradication, Acadia Quest, the Acadia Digital Media Team, the night sky initiative, the peregrine falcon and hawk watch program, Acadia Teacher Fellows Program, water quality monitoring and a volunteer program that typically contributes over 5,000 hours of time per year to help maintain Acadia's trails and carriage roads.
