National Trails Day

Proposed Salmon Farm in Frenchman Bay

Friends of Acadia is among a number of stakeholders around Frenchman Bay raising questions about a proposal by American Aquafarms to lease two 60acre sites for salmon farms near Bald Rock and Long Porcupine Island. Each lease site would include fifteen pens (147-foot in diameter each) and a feed/generator barge.







American Aquafarms must apply for permits from the Maine Departments of Environmental Protection and Marine Resources and the U.S. Army Corps of Engineers. The permit applications have not yet been made public, but Friends of Acadia has concerns related to the scale of the proposed farms, noise and lighting, navigation, water quality, and impacts to the scenic viewshed from Acadia's carriage roads and motor road system, which are on the National Register of Historic Places. Friends of Acadia wrote to the Army Corps of Engineers encouraging the agency to require American Aquafarms to complete a full Environmental Impact Statement given the significant environmental controversy over the proposal. Stay tuned for future alerts about opportunities for public comment on the salmon farm proposal.

Beer to Benefit Acadia






